Join us for a fun winter challenge! The run is a three hour event that takes you on a 1.6 mile loop set in beautiful R.B. Winter State Park. You choose your challenge! In **RC Revolutions** your goal is to run/walk the loop as many times as you can or only as many times as you'd like in those three hours. Looking for a challenge with a new twist? How about taking part of the **Last Man Standing**? You get 20 minutes to complete the first loop (12:30-minute pace). At the end of that lap, you wait for loop 2 for which you will have 19 minutes for completion (11:52-minute pace). Time keeps counting down: 18, 17, 16, etc., until we're down to a 6-minute pace and probably the end of the race. If you don't finish a loop on time, you're "out." If you're "out" you don't have to pack up and go home, in fact, we'd love for you to stay, keep running, and/or cheer on everyone else! The hardest part of the challenge might be pacing yourself at the start, it might be the starting and stopping, or it might be the bitter cold, but we're sure to have some fun! Awards for top three male & top three female competitors in both challenges. Race shirt, custom medals & snacks guaranteed to those pre-registered, limited supply on race day. Race day registration opens at 7:30am. All proceeds split between Geisinger's Autism & Developmental Medicine Institute and the Operation Jack Autism Foundation
